## <u>Attendance</u>

Gosforth Academy staff work with students and their families to ensure each student attends school regularly and punctually. Excellent attendance and punctuality prepare your child for the world of work and supports the development of friendships and relationships. Gosforth Academy wants your child to have the education and skills they need to live a happy and fulfilling life. Regular school attendance is essential for all our students to make good progress. Every student at Gosforth Academy, in line with the Government's expectations, is expected to maintain an attendance level of 97% and above. All stakeholders have the responsibility to ensure this is achieved. There is the expectation that all students will attend the academy when it is in session.

The table below shows how school attendance equates to days absent from school.

Attendance over One School Year

98% attendance	less than 4 days absent from school
95% attendance	less than 10 days absent from school
90% attendance	4 weeks absent from school
85% attendance	5 ½ weeks absent from school
80% attendance	7 ½ weeks absent from school
