GOSFORTH ACADEMY PROVIDER ACCESS POLICY

This policy statement sets out the school's arrangements for managing the access of providers to pupils at the school for the purpose of giving them information about the provider's education or training offer. This complies with the school's legal obligations under Section 42B of the Education Act 1997.

Student entitlement

All students in Years 8-13 are entitled:

- to find out about vocational and technical education qualifications and apprenticeship opportunities, as part of a careers programme which provides information on the full range of education and training options available at each transition point
- to hear from a range of local providers about the opportunities they offer, including vocational and technical education and apprenticeships
- to understand how to make applications for the full range of academic and technical courses

Opportunities for access and management of provider access requests

Our annual Careers Convention is an all-day event held on our November Review Day, and gives providers the opportunity to speak to our students (and parents in the case of Years 9-11), alongside employers from a wide range of sectors. All students in Years 9-11 come into school with parents to attend a review appointment with their plan manager and must also attend this Careers Convention to complete a research task before their appointment. Sixth Form students are also strongly encouraged to attend.
